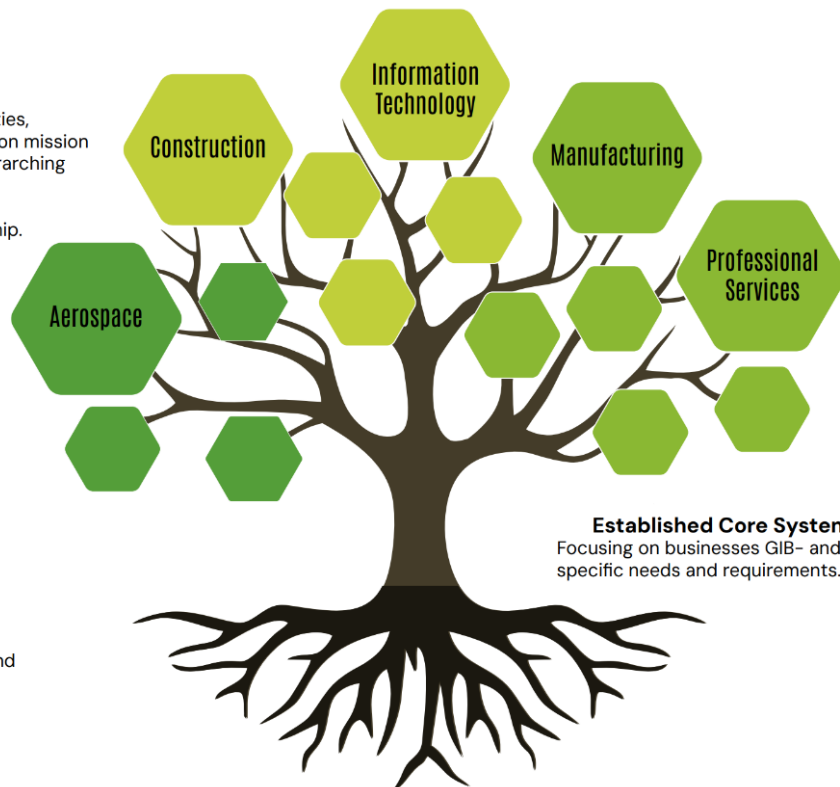
An interactive training platform allowing Fellows & Senior Fellows to engage in activities that nurture and advance healthy business ecosystems.

Identified and selected from NVSBC’s network of GovCon experts and highly successful VOSB and SDVOSB owners, Senior Fellows are recommended directly to participating business owners by NVSBC staff—ensuring personal introductions and the signature NVSBC “personal touch.”

As experienced leaders, Senior Fellows provide mentorship, specialized expertise, and community leadership that enrich the Fellowship experience. They help guide current Fellows through complex federal contracting challenges, contribute to program quality, and elevate the broader veteran small business ecosystem. Senior Fellows embody the values of service, expertise, and collaboration that define the NVSBC community and play a vital role in sustaining a strong, connected, and mission-driven Fellowship network.
